Edric's wisdom seemed powerless against the tide of misfortune threatening to engulf the realm."

#3: "Summoning his courage, he tackled Colette, and they struggled for the tomb. In the chaos, Wulfric managed to tear a page from the book. He recited a counter-spell from memory, words he had painstakingly memorised. A blinding light filled the room, and the tome disintegrated in Colette's hands. The kingdom stabilised, the fields regaining their bounty, and the gold returned to the coffers. Colette, stripped of her power and fled the castle in disgrace."

a. Strengths:

- Fast-paced action that creates tension
- Satisfying resolution to the conflict

b. Weaknesses: Rushed Climax: The resolution of the conflict happens too quickly, diminishing the impact of the struggle. You rush through Wulfric's actions and the spell's effects without giving the reader time to fully engage with the climactic moment. For instance, "A blinding light filled the room, and the tome disintegrated in Colette's hands" happens so abruptly that it lacks emotional weight.

c. Exemplar: "Summoning his courage, Wulfric lunged at Colette, his fingers desperately grasping for the tome. In the ensuing struggle, he managed to tear free a single page. With trembling voice, he began to recite the counter-spell, each word feeling like fire on his tongue. As the final syllable left his lips, a blinding light erupted from the page, engulfing the room in its radiance."

Actionable Task: Rewrite the climactic scene (paragraph beginning with "Summoning his courage"), focusing on slowing down the pace and adding more sensory details to heighten the tension and emotional impact of the moment.
