### #1 (First paragraph): a. Strengths:

b. Weaknesses: Main issue: Overstatement Your writing tends to exaggerate the potential consequences. For example, "these cringe photos are years and years behind you, it can still emerge in an interview" assumes that all childhood photos will resurface and negatively impact job prospects. This overgeneralisation weakens your argument.

c. Exemplar: "While not all childhood photos will impact future job prospects, some inappropriate images shared online could potentially resurface during the hiring process, potentially influencing an employer's perception."

### #3 (Final paragraph): a. Strengths:

- Attempts to summarise main points
- Reiterates the central argument

b. Weaknesses: Main issue: Repetitiveness Your conclusion largely restates points already made without offering new insights. For instance, "Photos may not look like a threat but when it is revealed to the wrong people, it can cause enormous damage" echoes ideas from earlier paragraphs without deepening the discussion.

c. Exemplar: "In conclusion, while sharing children's photos online may seem harmless, it can have far-reaching consequences for their privacy, emotional well-being, and future

opportunities. Empowering children to have a say in their digital presence is crucial for their long-term welfare."
