#1 (First paragraph): Strengths:

- Your opening hook effectively uses an imaginative scenario to capture reader interest
- Your clear thesis statement presents your position on Japan's economic model

Weaknesses: Underdeveloped Context → Your introduction lacks specific historical context about Japan's post-war economic transformation. The phrase "one that occurred in Japan in the post WWII era" is too vague and needs elaboration on key aspects of this revolution.

Exemplar: "Imagine this: countries once devastated by poverty transforming into economic powerhouses, just as Japan did through its remarkable post-war industrialisation of 1950-1970, while preserving their cultural heritage."

#2 (Second paragraph): Strengths:

- Your topic sentence clearly states the main argument about poverty reduction
- You logically connect productivity to economic efficiency

Weaknesses: Lack of Specific Evidence → Your claims about productivity and efficiency remain abstract. The statement "By embracing Japan's style of economy, the country will become more productive" needs concrete examples of Japanese economic policies and their outcomes.

Exemplar: "By adopting Japan's export-oriented industrialisation and strategic government-business partnerships, developing nations can boost productivity, as evidenced by Japan's average annual GDP growth of 10% during the 1960s."

#3 (Fourth paragraph): Strengths:

- Your counterargument acknowledges cultural concerns
- You attempt to address potential criticisms of the model

Weaknesses: Superficial Analysis → Your rebuttal lacks depth in explaining how economic modernisation and cultural preservation can coexist. The claim that "more social interaction will take place" oversimplifies complex cultural dynamics.

Exemplar: "While some governments fear cultural erosion, Japan's experience demonstrates how economic modernisation can actually strengthen cultural identity through increased cultural exports, tourism, and international recognition, as seen during the 1964 Tokyo Olympics."

Actionable Task: Rewrite your second paragraph incorporating specific examples of Japanese economic policies (e.g., keiretsu system, export promotion, industrial policy) and their measurable impacts on development.

Another reason is that, like mentioned in the last paragraph, it does not leave negative financial and economic implications when countries switch from their old economy to this one. Yes, at first people may need to be more productive and have longer working hours, but these temporary disadvantages are soon outweighed by the long-lasting benefits overall to the country. These benefits are trialed [tried] and proved true by Japan, which initiated the revolution, which wipes away the question about reliability.
