#1 Opening paragraph Strengths:

- Your vivid imagery effectively creates an emotional impact through the description of suffering children

#2 Second paragraph Strengths:

Weaknesses: Circular Reasoning → Your argument repeats the same point without developing it further. The statement "As said before, animal lives are worth less than human ones" simply restates your opening claim without providing new support or deeper analysis.

Exemplar: "While we must treat all life with respect, the potential to save millions of human lives through controlled animal testing outweighs the cost, as demonstrated by successful medical breakthroughs like the polio vaccine."

#3 Final paragraph Strengths:

- Your attempt to link to concrete examples like the common cold
- Your connection to future possibilities with cancer research

Weaknesses: Insufficient Development → Your conclusion about preventable diseases lacks specific examples or evidence. The parenthetical note "(It can actually be fatal)" interrupts your argument's flow without adding substantive support.

Exemplar: "Without animal testing, research into treatments for diseases ranging from the common cold to cancer would be severely limited, potentially leaving us unable to develop life-saving medications and vaccines."

#1 Should Animal Testing be Ethical
