Strengths: Your introduction clearly states the purpose of your email and mentions the growing population as a reason for concern.

Weaknesses: Imprecise language → The phrase "starts to skyrocket" doesn't provide specific information about how much the population has grown. Your sentence structure is also repetitive with "more and more people are present."

Strengths: Your conclusion summarises the main points discussed in the email, mentioning economic, social and environmental benefits.

Weaknesses: Vague phrasing → The phrase "helping hand" is too casual and doesn't clearly convey how significant the parks would be. You also introduce the idea of safety which wasn't discussed in the main body of your email.

To conclude, adding more parks would significantly benefit our entire community through economic advantages, increased social connections, and a healthier environment for all residents.

■ Your email presents a good structure with an introduction, body paragraphs covering different benefits, and a conclusion. However, your explanations need more specific examples to convince the council. For instance, when you mention "social cohesion," you could describe how families might gather for picnics or how neighbours might meet while walking. Also, your sentences sometimes contain grammar mistakes that make your ideas harder to understand. Try reading your email aloud to spot confusing parts. Additionally, some of your claims like "renowned suburb" need clearer explanation. Make sure each paragraph fully develops one main idea before moving to the next. You could also improve your email by adding a specific request, such as asking for a particular location for a new park or suggesting a reasonable timeline for development.
