Your first paragraph could be stronger by stating your purpose more directly. Also, your arguments would be more convincing if you included direct examples of community members who benefit from the library. The letter would be more persuasive if you acknowledged potential reasons for the demolition and addressed them. Additionally, your conclusion could offer a specific solution rather than just asking for the demolition to be cancelled. You could improve paragraph three by focusing on specific programs at Elderberry Street Library rather than making general claims about libraries.
