

Section 1:

#1 Strengths: Your opening paragraph effectively establishes an emotional tone with vivid imagery. You've made a clear connection between the playground's condition and children's well-being.

Weaknesses: Overly dramatic language → Your writing uses excessive emotional language that undermines credibility, particularly phrases like "heart weighed by the agony" and "barren wasteland." The reference to specific regulations lacks context and clarity, as in "Section 3.6.2, paraphrase 7."

Exemplar: ***I write with serious concern about the dangerous conditions at Silverwater Heights playground, which no longer provides a safe environment for our students. Based on the council's own safety requirements (Section 3.6.2), this playground requires immediate attention.***

#2 Strengths: Your use of a real-world example with Evan Mane personalizes the issue effectively. You've created a compelling narrative that illustrates the real consequences of the playground's condition.

Weaknesses: Exaggerated imagery → Your description includes unnecessarily graphic and melodramatic language, such as "seeing not just the playground, but Death behind it" and "eternal agony suffered by children." The repeated rhetorical questions about sleep feel accusatory rather than persuasive.

Exemplar: ***Evan Mane, a kindergartener who dreams of becoming an astronaut, suffered a serious leg injury after falling from the unsafe climbing frame. He now uses a wheelchair, which has significantly impacted his daily activities and confidence. This accident represents just one of many preventable injuries that continue to occur.***

#3 Strengths: You've acknowledged opposing viewpoints about economic concerns, which strengthens your argument. You've offered specific alternatives like using the Council Emergency Funds.

Weaknesses: Unsupported claims → You mention property values "plummeting at an abysmal rate of 45% per annum" without providing the source of this information. The false dichotomy between "a haven that benefits all, or cold green cash" oversimplifies the decision-making process.

Exemplar: ***While budget constraints are a legitimate concern, the ongoing medical costs from playground injuries and the declining neighbourhood appeal suggest that repairing the playground would be economically beneficial in the long term. According to council code 2.4.6, this situation qualifies for Emergency Funds allocation.***

■ Your persuasive piece has a strong emotional appeal and clear purpose, but its effectiveness is reduced by overly dramatic language. Consider toning down extreme phrases to make your argument more credible. The piece would be stronger if you provided more specific details about the required changes rather than focusing on graphic descriptions of injuries. Your discussion of funding solutions is a strength, though it needs clearer explanations. Also, try replacing accusatory questions with more constructive suggestions for action. The playground safety issues are compelling on their own without exaggeration. Your conclusion should focus more on specific actions and timeline expectations rather than presenting a moral ultimatum. Try rewriting the opening and conclusion paragraphs to use more measured language while still conveying urgency.

Dear Councillor Williamson,

#1 I write to you with a heart weighed by the agony that students face as they step inside of Silverwater Heights playground, a playground that Silverwater Public School adopted for children to jubilantly play in. Now it is a ~~barren wasteland~~ [deteriorating area] that is not only eroding itself, but also our joy, and safety. According to Section 3.6.2, paraphrase 7 of the safety requirements that every structure must have, the very safety standards that you had enforced, this playground is ~~inhabitable~~ [uninhabitable], and should be evacuated from. This playground lies in your jurisdiction, and so I request your help to revive this now ~~blinded~~ [neglected] monstrosity.

Silverwater playground's metallic deteriorating gaunt frame reflects the smell of blood when children face lacerations from it, not just physically but mentally. The ~~tantalising~~ [tantalising] monkey bars are far too high in the air to provide any chance of surviving. The chains that hold the swing together have oxidised and are corroding, like daggers awaiting their victim. Over the course of 3 years, this playground has led to 43 fractures, 24 of them being complex fractures (when the bone is sticking out of the skin). "39% of youth hospital visits in our district have been because of this playground, the rest occurring from other hazardous playgrounds.", Dr. Emily Wilson, a senior nurse at Silverwater Hospital proclaims, "There are even multiple returning visits from children who had been severely injured because of the playgrounds

#2 Last month, I saw kindergartener Evan Mane, who dreams of being an astronaut, fall off the climbing frame, and twist his entire leg, letting out a ~~cacophonous~~ [cacophonous] screech that

didn't just carry pain, it carried the betrayal of trust of the playground's safety. His small body crumpled when he hit the ground, seeing not just the playground, but Death behind it. Now he is in a wheelchair, his ambitions demolished. I still hear the morbid scream whenever I look at the playground. ~~How can you sleep at night seeing the eternal agony suffered by children? How can you sleep at night hearing the screeches of children, when they fall off the playground that you commissioned to be built? How can you sleep at night knowing that this is your responsibility?~~ [As our elected representative, you have the responsibility and authority to address this ongoing safety issue that continues to harm children in our community.]

#3 Opponents of rehabilitating the playground may argue that rebuilding the playground would imbalance economic stability, and that the playground is just a structure built for joy. I understand that this perspective may be true, as it acknowledges real-life cost, and questions the need of the playground. However, I believe otherwise, as this playground causes injury that costs more to heal than to rebuild the playground, and that the playground is an epitome for not only joy but also to maintain fitness and to stay healthy. Additionally, property values around the area are plummeting at an abysmal rate of 45% per annum due to the unwanted playground. Thus, the economic argument, while realistic, fails to consider the other factors that the playground could provide, and the economic hardship that now is happening because of it.

Our research shows that the Council Emergency Funds could pay for the rebuilding of the playground, as outside of school hours community members use this playground, and that according to council code 2.4.6, this situation is considered an accurate use for the emergency funds.

I, along with the other students at my school request an immediate safety inspection as soon as possible to analyse the changes needing to be made to the playground. Our community deserves a trustworthy playground that offers safety and fitness, and your leadership is the only way to do this. ~~Either choose between creating a haven that benefits all, or cold green cash.~~ [We hope you will prioritise the safety and wellbeing of local children by approving this necessary renovation.]
