

Re: Immediate Action Required - Australia's Oceans' Marine Life Populations are Deteriorating

Dear Local Member of Parliament Harry Jones,

I write to you to express my deep concerns regarding the decline of Australia's marine life population, and implore you to implement sustainable practices in our nation, to protect Australia's biodiverse underwater ecosystems. Our oceans have mutated from an idealistic Atlantis to a grim intoxicating tomb. It leaves nuclear mushroom clouds that sluggishly poison animals to death, contains venomous microplastics, invisible infiltrates that torment animals to death, and has baneful metal cans choking all of the aquatic animals that are left. This matter lies between your jurisdiction, and your decision is crucial to amend our sea's muffled, dying heartbeat.

Analysis conducted by EPA (Environment Protection Australia), reveal that the 2000 water samples collected across several coasts all indicate elevated uniform pollution levels, having high concentrations of microplastics and nutrient contaminants. An average of 84% of the water in samples that were sea-level contained microplastics, and 98% of water in samples that were 100 metres below sea-level had microplastics. Additionally, EPA found a correlation between coasts that had non-pollutant waters, and the number of industries, ship routes and sewage that are in close proximity that likely contaminated the water. Furthermore, Ecologist Anne Goodsman of EPA proclaims "Our oceans are filled with toxic nitrates, microplastics, harmful bacteria, dangerous parasites, phosphates, and even radioactive substances - all because of us."

Our ocean swallows the detrimental clouds of smoke we create, saving us from our own weapon, and is a gargantuan barrier that shields us from the maelstrom of climate change we created. Although, the barrier is corroding, and our production of greenhouse gases is exponentially growing. Every torrent of smoke that we unleash leaves a trail of acidity that envenoms several species to the pinnacle of extinction. Every vortex of pollution that we set loose burns the waters, tormenting animals, and causing a rise of the sea-level, which drowns multitudes of coastal cities. Every wildfire of carbon dioxide that we release can deteriorate oxygen levels, resulting in countless deaths of aquatic animals. Who will save this altruistic, dying heartbeat?

Opponents of depolluting the ocean may argue that the entire sterilisation of the ocean will require immense funds that are unviable, and that our actions will be too minor to decrease the pollution of the ocean. I understand this perspective as it looks at the economic argument, and it acknowledges the reality of our actions. You will either stand as the guardian of our nature, or kneel as the assassin of our oceans. You will either be hailed for your magnanimous actions, or condemned for your selfish misdeeds.
