You could explain how the tax system directly funds environmental restoration projects, or how better transport helps citizens participate in conservation efforts. Adding a short paragraph about potential challenges or opposition would make your leadership vision more realistic. Try focusing on one specific region of Altheria as an example of how these laws would improve life for citizens there.
