## Section 1

#1 - Opening paragraph with the vivid scenario and main argument

**Strengths:** Your opening creates a clear picture with the 7-year-old crossing the road, which helps readers understand why this topic matters. You also state your main argument clearly - that pedestrian crossings with flashing lights should be added next to schools.

Weakness: Vague supporting evidence → Your paragraph mentions that "thousands of children experience this every day" but doesn't explain where this number comes from or provide specific details about how often accidents actually happen near schools. The connection between your opening scene and the broader problem could be stronger.

Exemplar: Research shows that 15% of pedestrian accidents involving children occur within 200 metres of schools, making safe crossing points essential for student safety.

#2 - Second paragraph about driver attention and safety statistics

**Strengths:** You mention that experts have research about flashing lights being more effective, which shows you understand the importance of using evidence to support your points.

Weakness: Incomplete evidence presentation → When you write "Experts have proven that pedestrian crossings with flashing lights have a significantly lower rate than ones with no flashing lights," you don't finish explaining what the "lower rate" refers to - accidents, injuries, or something else? You also don't say which experts or studies you're referring to.

Exemplar: According to transport safety researchers, pedestrian crossings with flashing lights reduce accident rates by 40% compared to standard crossings without signals.

#3 - Final paragraph with the counterargument about distracting drivers

**Strengths:** You attempt to address what people who disagree might say, which shows you're thinking about different viewpoints on this issue.

Weakness: Weak counterargument response → Your response about LED decorations at restaurants doesn't really connect to the serious topic of road safety. The comparison between restaurant lights and traffic safety signals isn't convincing because they serve completely different purposes.

Exemplar: While some worry that flashing lights might distract drivers, traffic studies demonstrate that these signals actually improve driver focus by clearly marking where pedestrians will cross.

■ Your piece tackles an important safety topic and shows you care about protecting children. You've structured your argument with clear reasons - safety, education, and traffic flow - which helps readers follow your thinking. However, your writing would benefit from stronger evidence and more detailed explanations. Additionally, you could improve how your ideas connect to each other by using better transition phrases between paragraphs. Also, some of your sentences repeat the same ideas, particularly your conclusion, which makes your argument feel less powerful. Furthermore, you could strengthen your writing by being more specific about the problems you're trying to solve and providing clearer examples of how pedestrian crossings actually work to improve safety.
