#1: Introduction (First Paragraph)

Strengths:

- Your opening clearly states your main point that libraries are important to people
- You mention several specific benefits like free access, quiet reading spaces, and community areas

Repetition and Wordiness \rightarrow Your introduction says similar ideas multiple times in different ways. The phrase "In my opinion I definitely believe" uses two expressions that mean the same thing. You also repeat the idea of libraries being "essential" twice in the first sentence. Additionally, you write "helping not just one but all" when you could simply say "helping everyone." When you repeat ideas too much, readers can lose interest in your message.

Exemplar: Libraries are essential to humanity because they provide free access to books, quiet spaces for reading, and community areas where people can connect.

#2: Second Body Paragraph (Technology Paragraph)

Strengths:

- You recognise that libraries offer important technology services beyond just books
- You mention specific examples like e-books, laptops, and Wi-Fi hotspots

Unclear Connection Between Ideas → Your paragraph jumps between different technology topics without smooth links. You start by mentioning "e-books to listen to," then suddenly shift to "the bridge that the digital world divides" without explaining how these connect. The phrase "digital world divide" also appears twice with slightly different wording ("bridge the digital world divide"), which confuses your message. Readers need clearer signposts to follow your thinking from one point to the next.

Exemplar: Libraries bridge the digital divide by providing free access to technology. They offer computers, internet connections, and training programmes that teach people how to use digital tools. This access is especially important for people who cannot afford their own devices.

#3: Environmental Paragraph (Third Body Paragraph)

Strengths:

- You attempt to compare different environmental impacts of books versus e-readers
- You show awareness that environmental issues have multiple sides to consider

Weak Link to Main Argument → Whilst you discuss environmental facts about books and e-readers, you don't explain clearly why this matters for libraries specifically or how it supports your argument. The paragraph mentions that "paper books have a large upfront impact" and "e-readers have a significant carbon footprint," but it doesn't tell readers whether libraries help or harm the environment overall. You introduce "stewardship for the environment" but never return to explain what libraries actually do to protect nature.

Exemplar: Libraries help the environment by allowing many people to share the same books instead of everyone buying their own copies. When twenty people borrow one book from the library, this creates less waste than twenty people purchasing twenty separate books. This sharing model reduces paper use and helps protect forests.

Your writing shows you understand that libraries are valuable, and you've identified several important reasons why. However, your piece would be stronger if you developed each idea more deeply. Right now, many of your paragraphs list facts without explaining why those facts matter or how they connect to real people's lives. For instance, in your first body paragraph, you mention that libraries "enhance education by helping with literacy" and "promote social inclusion," but you don't give examples of what this looks like in practice. Try adding a sentence or two in each paragraph showing a specific situation where a library makes a difference—perhaps a student who uses the library to complete homework, or a new immigrant who learns English through library programmes.

Additionally, your paragraphs sometimes present two or three separate ideas that compete for attention rather than working together. Your technology paragraph talks about e-books, the digital divide, hardware access, and online resources all at once. Pick your strongest point in each paragraph and build your explanation around that one idea. Also, some of your sentences try to say too much in one breath, making them difficult to follow. The sentence beginning "The bridge that the digital world divides" attempts to cover multiple concepts but ends up confusing readers. Break longer, complicated sentences into two shorter ones. Finally, your conclusion repeats points from your introduction without adding new insight. Use your conclusion to remind readers why libraries matter beyond just listing their features again—perhaps by imagining what communities would lose if libraries disappeared.
