

## Section 1:

### #1: Opening paragraph

#### Strengths:

- Your opening uses direct questions to engage readers immediately, which helps draw them into your argument.
- You clearly state your position that the community needs a police station rather than a sports complex.

**Weak topic sentence structure** → Your opening lacks a smooth introduction to the topic. The phrase "Do you feel that your community doesn't feel safe?" contains awkward repetition with "feel" appearing twice in close succession. Additionally, jumping straight into rhetorical questions without establishing context makes your argument feel abrupt. Your thesis statement arrives too quickly without building up to it, which weakens the persuasive impact.

**Exemplar:** *Have you ever worried about safety in your neighbourhood? Many communities face the challenge of deciding how to spend limited resources, and our area must choose between building a police station or a sports complex. For the safety and wellbeing of all residents, a police station is the clear priority.*

### #2: Body paragraph about Tilly's story

#### Strengths:

- You provide a specific example with the character Tilly, which helps illustrate your point about reporting crime.
- Your rhetorical question "What would have happened if there was no police?" prompts readers to consider consequences.

**Underdeveloped supporting evidence** → Your example about Tilly feels rushed and lacks necessary detail to be convincing. The phrase "wrestling a young girl" is vague and doesn't clearly explain the danger. You also shift too quickly from the incident to the conclusion without explaining how police intervention specifically helped. The comparison "If the sports complex was built, what would they be able to do about it?" feels weak because you don't acknowledge that both facilities could exist or explain why one prevents the other.

**Exemplar:** *For instance, when Tilly witnessed a suspicious person attempting to grab a young girl near the local shops, she immediately contacted emergency services. Within minutes, police officers arrived at the scene, intervened safely, and ensured the child returned home unharmed. Without a local police station, response times would be significantly longer, potentially allowing dangerous situations to escalate.*

### #3: Conclusion paragraph

## Strengths:

- You restate your three main reasons, which helps reinforce your argument.
- The phrase "safety FIRST" creates a memorable ending that links to common safety messages.

**Repetitive structure without deeper reflection** → Your conclusion simply lists the same points again without adding new insight or making a stronger final appeal. The sentence "Should there be a police station and not a sports complex?" raises the question again but doesn't answer it with additional persuasive force. You miss the opportunity to acknowledge opposing views or explain the broader community benefit, which would strengthen your position. The conclusion reads like a summary rather than a powerful closing statement.

**Exemplar:** *Ultimately, whilst recreational facilities enhance our quality of life, they cannot replace the fundamental need for community safety and security. A police station provides crime prevention, emergency response, and peace of mind that protects every resident, every day. Our community's wellbeing depends on making safety the foundation upon which all other improvements can be built.*

■ Your piece presents a clear argument, but it needs more depth to be truly convincing. The examples you've chosen feel simplistic and don't fully explore why a police station specifically addresses community needs better than alternative solutions. Additionally, you haven't considered that some readers might value both facilities or question whether a sports complex could contribute to crime prevention through youth engagement. To strengthen your writing, develop each body paragraph more thoroughly by explaining the consequences in detail and connecting your points back to broader community wellbeing. Also, your second body paragraph about reporting missing items feels less urgent than the others—consider whether reporting a lost dog carries the same weight as preventing violent crime, and perhaps choose a stronger example that better supports your safety argument.
